Gold Star Families Memorial Monuments (GSFMMs): GSFMMs provide a place of permanence intended to demonstrate to Gold Star Families that their community cares for them and honors their enduring sacrifice while also honoring their Loved Ones who paid the ultimate sacrifice while serving in the Armed Forces of the United States of America. The GSFMMs help to establish and strengthen Gold Star Family communities across the nation through events held at each monument location. These activities help to educate the general public about the price of freedom and encourage community involvement. 2020 Metrics: Over 150 communities in all 50 states and one US Territory, 79 GSFMMs completed/dedicated, 73 GSFMMs in progress, 8500 Gold Star Family members brought together.

Community Outreach & Education: After the dedication of each Gold Star Families Memorial Monument, the foundation is focused on keeping each community engaged through sponsoring hosting outreach programs and events events. These events include memorial events, 5K runs and walks, motorcycle rides held Monument to Monument, riverboat gatherings, school visits, educational programming, and events involving professional sporting events. These events provide opportunities for Gold Star Families to come together, honor their Loved Ones, and build a community-based system of support and awareness. 2020 Metrics: 150+ Events, 50K+ in attendance, 23K+ virtual attendees.
